Svitlana's research interests include sociology of education, education reform, quality assurance in secondary and higher education. She is the editor-in-chief of the international peer-reviewed journal 'Youth in Central and Eastern Europe. Sociological Studies. In the framework of British Council in Ukraine she took part in Leadership Programme for Higher Education and visited Anglia Ruskin University (UK, 2016). Visiting Professor at the University of Warsaw, Institute of Applied Social Sciences (2015, Poland). 3. Tetiana Lisova	Docent of Department of Applied Mathematics, Informatics and Educational Measurement of Nizhyn Gogol State University. Candidate of Science (corresponding to PhD) in Mathematics and Physics. She was an active participant of the Tempus project "Educational Measurements Adapted to EU Standards" (2009-2012). Continues research in the field of educational measurement. His scientific interests include research of biased functioning of items in different groups, alignment of test results in different groups, mathematical modeling of tests. Teaches students at bachelor and master levels courses on Mathematical and statistical methods in behavioral science, Mathematical theory of tests, Probability theory and mathematical statistics, Control theory. Author of more than 80 publications in Mathematics and Educational Measurement. Participated in international conferences in Hungary, Spain and Morocco.
