2. PURPOSE AND OBJECTIVES OF THE DISCIPLINE "EUROPEAN REGIONAL POLICY"

2.1. Purpose of the discipline study.

The purpose of a given discipline is to study the methodology of formation and practical implementation of regional policy of EU countries and to develop on this basis the skills to solve strategic problems of regional development that are needed by experts in the international economy.

2.2. Objectives of the discipline study.

Objectives of the discipline study are: exploring the basic elements that simultaneously differentiate and integrate processes of globalization and regionalization; conducting a comparative analysis of the best practices of territorial reform in EU countries; presentation of the overall structure of Europe 2020, analysis of cross-border cooperation of euroregions at the EU border, identified initiatives to create clusters in Ukraine, applying the experience of implementing NUTS in the EU for Ukraine.

2.3. Name and description of competencies, which provides learning of the discipline:

- be able to apply the local approach of EU regional policy
- ability to analyze the effectiveness of public sector reforms in decentralization and self-government;

Performing and designing this task, students can use computers. Individual work evaluated on a 100-point scale. Fulfilling individual work is one of the most important modules of descriptive module on the discipline "European regional policy".

Individual work is prepared in the form of assignment which involves tasks of each topic.

The nature of writing the assignment is to study the regional socio-economic development of specific countries according to the following schedule:

- 1. Analysis of key regional development indicators.
- 2. Identifying factors of the regional economic development.
- 3. Main areas of the regional policy.
- 4. Cooperation with international organizations in the context of economic development.
 - 6. Impact of globalization on developing countries.
 - 7. Vision of the future directions of regional economic policy.

7. STUDENTS' SELF-STUDIES

Students' self-studies requires a special attention because a part of questions of each topic is given to study by students themselves. This work offers a number of teaching tools provided by the department to study a given discipline. Training materials provide the possibility of self-control (questions, test). To work for learning the discipline can be carried out in the reading rooms of university's library, computer classrooms as well as at home. The department provides consultations on specific most difficult topics of a course. Teachers of the department shall also the current and final control and analyze the results of students self-studies.
