2. THE PURPOSE AND TASK OF STUDYING THE DISCIPLINE «EUROPEAN UNION LAW»

2.1. The purpose of studying the discipline:

The **purpose** of studying the discipline is for students to acquire knowledge about the legal foundations of the formation of the European Union, the sources and principles of the European Union law, the foundations of the construction and functioning of the institutional bodies of the European Union, the legal status of a person and a citizen in the European Union. Special attention is paid to the analysis of the legal foundations of the internal market and common policies of the European Union, legal regulation of relations between Ukraine and the European Union.

2.2. The task of studying the discipline:

The **task** of studying the discipline consists in forming an understanding of the essence and peculiarities of the European Union law, the main theoretical foundations and genesis of European unity, institutional, legal, economic aspects of the functioning of the European Union, European integration policy of Ukraine.

2.3. Name and description of competencies, the formation of which ensures the study of the discipline:

- Ability to critically understand the theories, principles, methods and concepts of international law, European law, comparative law, to take into account the temporal factor and to predict the main directions of development of legal systems.
- Ability to form judgments in the field of international, European, national law, comparative jurisprudence, taking into account social, scientific and ethical aspects.
- Ability to interpret and apply the European Union law, to participate in the harmonization of Ukrainian legislation with the law of the EU, to provide legal support for the European and Euro-Atlantic integration of Ukraine.

2.4. Prerequisites for studying the discipline:

The study of the academic discipline "European Union Law" is carried out on the basis of the knowledge acquired by students from the academic disciplines "Politology", "History of international law", "Public international law (general part)", which leads to a more thorough study of the main categories and content of the European Union law.

2.5. Program learning outcomes:

- To know and understand the normative provisions, doctrines and principles of functioning of international and national legal systems, to analyze and qualify legal phenomena on this basis, to apply international legal norms and principles in the national legal system.
- To analyze the dynamics of harmonization of Ukrainian legislation with the European Union law, to take into account the legal aspects of European and Euro-Atlantic integration processes in solving complex professional problems.
- Communicate to specialists and non-specialists information, ideas, problems, solutions and own experiences on current issues of European and Euro-Atlantic integration, international, national and comparative law.
- Formulate conclusions, develop recommendations, justify one's own vision of ways to solve problems in the field of law-making, law interpretation and law enforcement.
- To know modern scientific achievements in the field of international and national law, to have skills in research work, to interpret the results of scientific research and to take them into account in practical professional activities.

Member of the European Parliament. Basic powers of political groups. Chairman of the European Parliament. Presidium of the European Parliament. Conference of heads of the European Parliament. Main spheres of powers of the European Parliament. European Council. Members of the European Council. President of the European Council. Council of the European Union. Formations of the Council of the European Union. Chairman of the Council of the European Union. General Secretariat of the Council of the European Union. Powers of the Council of the European Union. The European Commission. The main tasks of the European Commission. Composition of the European Commission. The procedure for appointing Members of the European Commission. Powers of the President of the European Commission. The judicial system of the European Union. Court of Justice of the European Union. Advocates General. Jurisdiction of the EU court. Jurisdiction of the General Court. Specialized courts. European Central Bank. Functions of the European Central Bank. Accounting Chamber.

6. STUDENT-SELF STUDY ON THE DISCIPLINE

Independent work, as one of the forms of learning educational material in free time from compulsory classes and without the participation of a teacher, involves a personally-oriented organization of a student's self-education. The organization of independent work requires special attention, because part of the questions of each topic is submitted for independent study by students, and the material provided for learning during independent work is submitted for examination.

Independent work is provided with the necessary educational and methodological tools (including lecture notes, educational and methodological developments for independent study of the discipline, periodicals). Students have the opportunity to independently work on educational material in the library, study rooms and computer classes using the Internet, as well as at home (upon receipt of the appropriate package of educational and methodological literature).

Independent work is a type of extracurricular individual work of a student of an educational, educational and research nature, which is used in the process of studying the program material of the academic discipline and is completed by assessment. The goal is to independently study part of the program material, systematize, deepen, generalize, consolidate and practically apply the student's knowledge from the course and develop independent work skills.

Independent work on the course "European Union Law" consists of independent scientific research of current, debatable issues in the European Union law. The result of independent work should be the demonstrated ability to consider an important scientific topic, classify different approaches to it, operate with special professional terminology in the field of European Union law, and express one's own understanding of the problem.

Independent work on the academic discipline "European Union Law" is aimed at deepening the student's knowledge, teaching him to think originally, non-standardly, independently, creatively. For this purpose, a variety of tasks are offered for the preparation of scientific work (essay, scientific article, theses), abstracts for scientific articles, participation in scientific conferences. The "Independent Work" module can be credited based on the results of confirmation by the relevant certificate of participation in the School of Polish and European Law, the School of European Union Law, the School of European Contract Law.

Types of independent work in the academic discipline "European Union Law":

- preparation of a scientific article or theses of a scientific report for publication;
- participation in Internet conferences;
- writing essays, performing creative tasks;
- reviewing scientific articles.

The type of independent work is agreed with each student separately.

The topics of independent work are also agreed individually.

7. TRAINING ON THE DISCIPLINE "EUROPEAN UNION LAW"

Training is a planned process of modifying (changing) the attitude, knowledge or behavioral skills of the student through the acquisition of learning experience in order to achieve effective performance in one type of activity or in a certain field. Training (from the English to train - to educate, teach) is a set of exercises for training in something.

Training is an indispensable element of the training system, which provides an opportunity to obtain new knowledge and experience in their practical use by developing new skills and abilities.

The purpose of conducting training is to acquire new professional skills and abilities by the participants of the training, to form skills of cooperation, critical and logical thinking, analysis, selection and presentation of information, and to find effective ways to solve the problems posed by combining the efforts of the participants in the training group.

Recommended procedure for student preparation and participation in the training: a) independent study of relevant scientific literature and case law; b) participation in a discussion within the framework of classroom training.

The training is held at the end of the semester with a summary by discussing the results of completed tasks, exchanging views on the issues raised in the lesson.

Training topics

- 1. Organizational and legal forms of cooperation between Ukraine and the European Union.
- 2. Action plan for implementing the state's strategic course for gaining full membership of Ukraine in the European Union and the North Atlantic Treaty Organization
 - 3. Objectives and methods of approximation of legislation.
 - 4. Current requirements for compliance with EU legislation.

Training procedure

- 1. Familiarize yourself with the provisions of the EU founding treaties.
- 2. Analyze the features of the state's accession to the EU.
- 3. Present the results of the analysis of a specific training topic in the form of a team project (for example, a plan of activities provided for in the association agreement).

8. ASSESSMENT TOOLS AND METHODS OF DEMONSTRATION OF LEARNING RESULTS

In the process of studying the discipline "European Union law", assessment tools and methods of demonstrating learning results are used: current survey; credit module survey; analytical reports, abstracts, essays; presentations of the results of completed tasks and research. The final form of control is an exam. When studying the subject «European Union law", the following teaching methods are used: lectures, seminar classes, individual classes, performing scientific works under the guidance of a teacher.

9. ASSESSMENT POLICY

Policy on deadlines and retakes. Specific deadlines are set for the completion of all types of tasks by students and the conduct of control measures.

Retakes of modules are carried out in accordance with the established procedure.

Policy on academic integrity. Cheating during control measures is prohibited. During the control measure, a student may use only permitted auxiliary materials or means, he is prohibited from exchanging information with other students in any form, using, distributing, collecting variants of control tasks.

Policy on attendance. Attendance at classes is mandatory, missed practical classes are made up. For objective reasons (for example, quarantine, martial law, illness, foreign internship), training may take place remotely in agreement with the course leader with the permission of the faculty administration.

10. CRITERIA, FORMS OF CURRENT AND FINAL CONTROL

The final score (on a 100-point scale) from the discipline "European Union law" is determined as a weighted average, depending on the specific weight of each credit component.

Current survey during the lesson:

- 90–100 points fully masters the educational material, freely and independently presents it in an argumentative manner during the answers, deeply and comprehensively reveals the content of theoretical questions;
- 75–89 points sufficiently fully masters the educational material, but when presenting some questions there is a lack of sufficient depth and argumentation, individual minor inaccuracies and minor errors are allowed;
- 65–74 points generally masters the educational material and presents its main content, but without a deep comprehensive analysis, justification and argumentation, while allowing individual significant inaccuracies and errors;

- 60-64 points not fully masters the educational material, presents it fragmentarily (without argumentation and justification), insufficiently reveals the content of theoretical questions, while allowing significant inaccuracies;
- 1–59 points does not possess the educational material, does not reveal the content of theoretical questions.

The final score for the current survey of each module is determined as the arithmetic average of the scores obtained during classes within each module.

Training:

- 90–100 points fully masters the training material, freely independently and with justification uses it when performing training tasks, shows a creative approach to performing tasks;
- 75–89 points sufficiently fully masters the training material, but when performing individual training tasks there is a lack of sufficient depth and reasoning for its use, individual minor inaccuracies and minor errors are allowed, in general, shows a creative approach to performing tasks;
- 65–74 points generally masters the training material and generally uses it when performing training tasks, but without a deep comprehensive analysis, justification and argumentation, while allowing significant inaccuracies and errors, in some moments shows a creative approach to performing tasks;
- 60-64 points does not fully master the training material, uses it fragmentarily (without reasoning and justification), does not sufficiently disclose the content of the training tasks, while allowing significant inaccuracies, does not demonstrate a creative approach to completing the tasks;
- 1-59 does not master the training material, does not disclose the content of the training tasks, does not participate in collective tasks during the training.

Student-self study:

- 90–100 points the content of the independent work fully meets the established requirements, contains elements of independent research, indicates a high level of mastery of the educational material, the student demonstrates a high level of creative approach to completing the tasks;
- 75–89 points the content of the independent work mainly meets the established requirements, there may be minor shortcomings in individual tasks, indicates an adequate level of mastery of the educational material, the student demonstrates a proper creative approach to completing the tasks;
- 60–74 points the tasks are completed at an insufficient level; the author's achievements are general and poorly substantiated, indicate an insufficient level of mastery of the educational material; the student makes significant errors in completing the tasks, in some moments demonstrates a creative approach to completing the tasks;
- 1–59 points the tasks are practically not completed; there are no author's achievements; gross errors in solving the tasks of the work, indicating a low level of mastery of the educational material; the student does not demonstrate a creative approach to completing tasks.

Modular work, exam - types of control in which the student's assimilation of theoretical and practical material is evaluated from 0 to 100 points as the sum of points for completed tasks.

The examination consists of:

tests: 20 tests, for each of which the student can receive 1 point for a correct answer, which ultimately gives a maximum of 20 points;

- 2 tasks (practical tasks): 2 tasks, for each of which the student can receive from 0 to 25 points, which ultimately gives a maximum of 50 points;
- 15–25 points fully masters the educational material, correctly solves the practical task and interprets the results obtained, demonstrates independence of execution.
- 5–14 points sufficiently masters the educational material, correctly solves the practical task, but there is no complete answer to additional control questions, allows minor inaccuracies and fragmentarily (without reasoning) interprets the results obtained, demonstrates independence of execution.
- 1–4 points does not fully master the material, solves the practical task fragmentarily, allows significant inaccuracies, presents it superficially, does not sufficiently reveal the content of the questions posed.

theoretical (problematic) question: 1 theoretical question, for the answer of which the student can receive from 0 to 30 points.

- 20–30 points fully masters the educational material, comprehensively, independently and with arguments presents it during the answer, deeply and comprehensively reveals the content of the task.
- 1–20 points generally masters the educational material, but not fully, presents it fragmentarily (without argumentation and justification), does not sufficiently reveal the content of the task, allowing significant inaccuracies, answers to questions are unclear.
