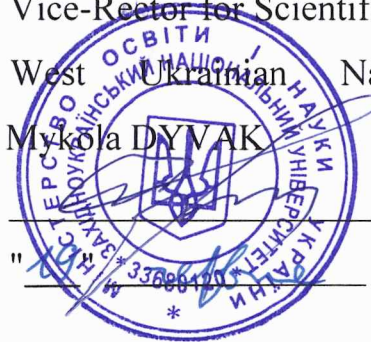

He Ting made a report on the main provisions of the qualification work, scientific novelty, and the most significant theoretical and practical results of the research that are being defended.

The applicant provided comprehensive answers to all questions asked.

TOOK THE FLOOR:

Doctor of Psychological Sciences, Professor Andriy Nestorovych Hirnyak (scientific supervisor) noted that the applicant He Ting has fully completed the educational and scientific program for the degree of Doctor of Philosophy in the specialty 053 Psychology, which is confirmed by the academic certificate of postgraduate study.

He Tin's qualification scientific work is a comprehensive scientific study of the features of the application of psychological knowledge in the system of youth socialization, professional development of higher education students and the development of verbal creativity of the individual, and therefore ensuring psychosocial conditions for the formation of professional creative abilities.

The problem of psychological conditions for the formation of professional creative abilities of an individual is poorly studied compared to the level of research on other features of the professional development of representatives of various professions. In addition, in this context, the issues of the personal and creative potential of a specialist, as a complex psychological characteristic, which is associated with his activity, productivity, subjectivity, resilience, self-determination, purposefulness and flexibility, are becoming significantly relevant.

So, the social challenges and unresolved scientific problems outlined above determined the relevance of the choice of the topic of the dissertation research "Verbal creativity in the structure of professional creative abilities".

Familiarization with the content of the dissertation allows us to state the appropriate level of scientific and practical validity of the researched issues and the reliability of scientific provisions. They are based on the use of systemic, structural-functional and resource approaches, philosophical, general scientific and special scientific methods of cognition. In particular, with the help of categorical-conceptual analysis and dialectical method of cognition, it was possible to reveal the essential content and general characteristics of the concepts of "metacreativity", "verbal creativity" and "professional creative abilities". Using critical and comparative analysis, the advantages and disadvantages of modern concepts and scientific approaches to the knowledge of the phenomena of verbal creativity and professional creative abilities were identified. The method of ranking and theoretical synthesis made it possible to distinguish the criteria for the system of regulatory factors for the formation of professional creative abilities of a specialist-professional personality in the system of verbal creativity development. The method of theoretical modeling was used in the development of a theoretical model of the structure of verbal creativity of the individual. At the same time, planning and design methods made it possible to develop a program of psychological support to promote the development of verbal creativity, and the methods of theoretical generalization and interpretation made it possible to formulate verified conclusions and applied recommendations for the phased and projective actualization of professional creative abilities.

To process the empirical indicators of the experimental study, mathematical statistics methods were used to establish relationships between regulatory factors of verbal and to verify the effectiveness of the program for developing verbal creativity of future specialists.

The information base of the study was regulatory and legal acts, materials of educational and psychological practice, scientific publications (monographs, dissertations, collections of scientific and practical conferences, etc.) on the researched issues and related areas.

The volume of literature reviewed, the applied systematic approach to research, and the methods of scientific knowledge made it possible to solve the outlined tasks and obtain verified author's proposals.

Novelty of the main scientific provisions, conclusions and recommendations. The presented qualification work contains a number of scientific provisions that have important scientific and theoretical significance and practical orientation.

In particular, the place of verbal creativity in the structure of professional creative abilities of future specialists is highlighted, as well as psychological predictors of verbal creativity of a professional specialist, among which creative activity and verbal intelligence play a leading role. At the same time, it is substantiated the main indicators of professional creative abilities, in particular speed, flexibility, originality of the creative product, and their connection with the verbal creativity of the individual. The idea of the specifics of the development of verbal creativity in specialists of various specialties has been expanded.

In the study, based on the results of theoretical analysis of the problem of verbal creativity, the ability to generate new and original ideas, concepts, thoughts was determined, which involves the use of language to create new concepts, images, decisions or emotions. It is shown that verbal creativity is an important tool for personal expression and social interaction and is included in a number of professional creative abilities. Correlations of verbal creativity with professional creative abilities were determined. In general, verbal creativity is positively related to verbal intelligence, in particular, indicators of speed and flexibility correlate with verbal-logical abilities. Speed, originality, and especially the sophistication of verbal creativity are positively correlated with the ability to abstract, and the ability to find analogies as combinatorial abilities are positively correlated with the sophistication of verbal creativity. The ability to build generalizations and make classifications is positively related to the sophistication, originality, and especially the flexibility of verbal creativity. These connections are more pronounced for students compared to working professionals.

The main provisions and conclusions formulated as a result of the research are reflected in 6 scientific publications, including 3 articles in scientific professional publications and 3 abstracts of reports presented at international and all-Ukrainian scientific and practical conferences.

Analysis of scientific articles and abstracts of reports published by the applicant at scientific and practical conferences makes it possible to ascertain the proper completeness of the presentation of scientific provisions, conclusions and recommendations formulated in the dissertation in published scientific works.

The structure, volume and content of the publications comply with the established requirements of the Ministry of Education and Science of Ukraine.

Thus, He Ting's dissertation on "Verbal creativity in the structure of professional creative abilities" is a complete and independent study that includes results that have quite significant theoretical and practical significance. The main provisions of the work are covered in the author's published works.

According to formal characteristics and qualitative parameters, the qualification work of He Ting "Verbal creativity in the structure of professional creative abilities" meets the requirements for scientific research for the degree of Doctor of Philosophy, and its author deserves to be awarded the degree of Doctor of Philosophy in the field of knowledge 05 Social and Behavioral Sciences with a specialty of 053 Psychology.

Doctor of Psychological Sciences, Professor, Professor of the Department of Psychology and Social Work of the West Ukrainian National University Furman A.V. (reviewer), who highlighted the positive aspects of He Ting's qualification work.

The doctoral candidate has carried out a thorough analysis of the problem of verbal creativity in psychology, proving that it is a key factor in the processes of learning, culture and professional activity, as it allows generating original ideas and solutions that are important in the modern world. The ability to manipulate words and create new statements is extremely valuable in literature, advertising, rhetoric and many other areas. Research shows that verbal creativity is formed under the influence

of multiple factors, in particular, the social environment, motivation, emotional intelligence and communication skills. The theoretical and methodological principles of the development of communicative and creative abilities of future specialists are also substantiated.

The dissertation further developed the system of tools and knowledge about the typology of verbal creativity of future specialists, and improved the means of developing verbal creativity of future specialists and psychodiagnostic tools for studying the level of development of verbal creativity of an individual.

The formulations of novelty indicated by the author are accurate and correspond to the tasks set and the conclusions obtained. The practical significance of the work lies in the development and implementation of a program for the development of verbal creativity of the personality of future specialists.

Thus, the qualification work of He Ting ""Verbal creativity in the structure of professional creative abilities" meets the requirements of the Ministry of Education and Science of Ukraine and the National Agency for Quality Assurance in Higher Education for dissertations for the degree of Doctor of Philosophy (PhD). Taking into account the above, we believe that there is every reason to recommend the qualification work for consideration by the one-time specialized academic council of the West Ukrainian National University in the specialty 053 Psychology.

Doctor of Psychological Sciences, Professor, Professor of the Department of Psychology and Social Work of the West Ukrainian National University Bunyak N.A. (reviewer), who noted that the qualification work submitted for review is distinguished by significant heuristic potential, which is manifested in the disclosure of a number of psychological correlates, typological features and psychological predictors of verbal creativity of future specialists.

The materials of the qualification work outline the problem of developing verbal creativity of future specialists, taking into account the specifics of professional activity, which gives grounds to assert a high level of scientific novelty and theoretical significance of this work. In particular, the place of verbal creativity in the

structure of professional creative abilities of future specialists is determined and psychological predictors of verbal creativity of future specialists are characterized, among which creative activity and verbal intelligence play a leading role.

The factor structure of the professional creative abilities of future specialists has been determined, which is represented by the following components: "Verbal-creative professional abilities", "Spatial-abstract thinking professional abilities", "Metacreative professional abilities", "Creative professional abilities", "Critical thinking and mathematical intelligence", "Inductive verbal thinking" of future specialists.

The qualitative characteristics of the qualification work of He Ting "Verbal creativity in the structure of professional creative abilities" indicate its compliance with the specialty 053 Psychology, the requirements of the Ministry of Education and Science of Ukraine and the National Agency for Quality Assurance in Higher Education for dissertations for the degree of Doctor of Philosophy (PhD). Taking into account the above, we believe that there is every reason to recommend the qualification work "Verbal creativity in the structure of professional creative abilities" for consideration by the one-time specialized academic council of the West Ukrainian National University in the specialty 053 Psychology.

Candidate of Psychological Sciences, Senior Lecturer of the Department of Psychology and Social Work Prytula O.A. (reviewer), who noted that the topic, content, tasks, theoretical and practical significance of the qualification work He Ting present a qualitatively new approach to the development of verbal creativity of specialists both in the theoretical aspect and in the applied one. Moreover, on the basis of psychodiagnostic research, the effectiveness of the program for the development of verbal creativity of future specialists through the use of means of forming professionally creative abilities of the individual was developed and tested.

Therefore, the submitted work, in terms of its scientific level, the research results obtained, and the proposals, meets the requirements for scientific works of

such a level that it can be recommended for consideration by a one-time specialized scientific council.

on the scientific novelty, theoretical and practical significance of the results of He Ting's dissertation, submitted for the degree of Doctor of Philosophy on the topic "Verbal creativity in the structure of professional creative abilities"

Justification of the choice of research topic and its connection with the university's scientific work plans

State national educational programs and standards require the modernization of the higher education system and determine strategic directions for its further improvement in order to ensure constant intellectual and creative self-improvement of the personality of the future specialist, the formation of his creative and spiritual potential as the highest values of the nation. The transformation of higher education is designed to form the professional creative abilities of a specialist capable of self-realization, capable of creating national and world examples of culture.

In modern psychological science, the phenomenon of verbal creativity finds its place in almost all paradigms as one of the most interesting and at the same time contradictory phenomena. This is primarily due to fundamentally different categorical approaches to the determination of creativity in general, the diversity of theoretical and methodological foundations for its research and development in science and practice. The relevance of this topic is due to the following objective contradictions between: the requirements of society for a successful, competitive, productive personality and insufficient study of the role of verbal creativity in ensuring high efficiency in the professional activity of a specialist; the provisions of the scientific post-non-classical paradigm, which focuses on the systematic study of the subject of activity in modern humanitarian cognition and insufficient study of the psychological factors of the development of verbal creativity; fragmentation in scientific knowledge on the issues of verbal creativity of a specialist and the demands of modern society regarding the psychological support of a creatively gifted individual.

The dissertation was completed within the framework of the research work of the Department of Psychology and Social Work of the West Ukrainian National

University on the topic: "Psychosocial detailing of social and personal events as a technology of thought-action" (state registration number 0123U104568).

The topic of the qualification work was approved at the meeting of the Academic Council of the West Ukrainian National University on May 26, 2021, minutes No. 9.

Aim, objectives and methods of research. Object and subject of research

The aim of the study is to identify the psychological features of the formation and conditions for the purposeful development of verbal creativity in the system of professional creative abilities of a specialist.

To achieve this goal, the following tasks were set and solved:

- 1) to carry out a theoretical analysis of the problem of verbal creativity in the structure of a specialist's professional creative abilities;
- 2) to determine the correlations between verbal creativity and professional creative abilities;
- 3) to identify the place of verbal creativity in the structure of professional creative abilities of future specialists;
- 4) to determine the professional specificity of verbal creativity of students and specialists;
- 5) to determine typological profiles of verbal creativity of a specialist's personality;
- 6) to construct regression equations to explain the level of development of a specialist's verbal creativity parameters;
- 7) to create a developmental program to develop the verbal creativity of future specialists.

The object of research is the phenomenon of verbal creativity of a specialist.

The subject of the study is psychological characteristics, development conditions, typology of verbal creativity and its place in the structure of a specialist's professional creative abilities.

***Scientific propositions developed personally by the dissertation candidate
and their novelty***

Scientific novelty and theoretical significance lie in the fact that that:

for the first time:

- the place of verbal creativity in the structure of professional creative abilities of future specialists is highlighted;

- psychological predictors of verbal creativity of future specialists have been identified, among which creative activity and verbal intelligence play a leading role;

expanded understanding of:

- the specifics of the development of verbal creativity in specialists of various specialties;

- connections between speed, elaboration, flexibility, abstractness of the name, originality and resistance to closure of verbal creativity with professional creative abilities of the individual;

- verbal creativity of the individual as a professional creative ability and an important tool for personal development and social interaction;

received further development:

- a system of knowledge about the typology of verbal creativity of future specialists;

improved:

- means of developing verbal creativity of future specialists;
- methods, techniques and technologies for psychodiagnostic determination of the level of development of a person's verbal creativity.

***The validity and reliability of the scientific statements, conclusions and
recommendations being defended***

He Ting's qualification work has a clear, logically constructed structure that meets the requirements for the nature and content of scientific works. A qualitative analysis of the content of the dissertation confirms that the scientific propositions, conclusions, and recommendations formulated are theoretically sound and reliable.

The reliability of the research results is ensured by the fact that they were obtained by the author in the process of using general scientific and special methods of cognition. Among the research methods used in the work, it is advisable to note: conceptual provisions of the activity approach, theoretical provisions about the professional activity of a specialist, professional creative abilities, the structure and patterns of development of verbal creativity, critical thinking, creative activity and metacreativity of the personality. Scientific provisions, conclusions and recommendations are distinguished by reliability, which is ensured by the use of a significant amount of professional literature, applied research in the field of psychology.

Practical significance of the work

The practical significance of the results obtained is that they can be used by psychologists of higher education institutions, management and teachers of higher education institutions to create conditions for promoting the professional creative abilities of future specialists, taking into account the revealed patterns, professional specifics and conditions for the purposeful formation of verbal creativity. The created verbal creativity test "Rory's Story Cubes" and the developed and tested program for the development of verbal creativity can be successfully used in the activities of practicing psychologists of higher education institutions.

The results obtained during the study, including the developed and tested program for the development of verbal creativity in the structure of professional creative abilities of the individual, were implemented in the educational and scientific process at the Ukrainian Scientific and Methodological Center of Practical Psychology and Social Work of the National Academy of Sciences of Ukraine (reference No. 86 dated 12/31/2024), Mukachevo State University (reference No. 82 dated 12/31/2024), and West Ukrainian National University (reference No. 82126-36/2986 dated 12/31/2024).
